- (a) A gravel road approximately 0.22 miles in length located in the SW  $\diamond$  of NW  $\diamond$  of Section 7, Township 21 N., Range 12 W. of Buffalo County, Wisconsin running through Nolls Dairy Farm. Presently named Reisch Valley Road,
- (b) A hard surface road approximately 0.2 miles in length that is located in the SE  $\diamond$  of NE  $\diamond$  of Section 32, Township 21 N., Range 12 W. Buffalo County, Wisconsin running through Shirl Averbeck property. Previously named Averbeck Road.
- (c) A gravel road approximately 0.20 miles in length that is located in the NW  $\diamond$  of SW  $\diamond$  of Section 34, Township 21 N., Range 12 W., Buffalo County, Wisconsin, running through the Frank J. Jilot, et al property. Previously name Seifert Hill Road.
