TOWN OF BELVIDERE DRIVEWAY ORDINANCE

On December 9, 2009, The Town of Belvidere Board approved Ordinance #2009 - 05. This Ordinance will regulate all modifications or reworking of existing or new driveways/field roads that abut any TOWN ROAD within the Township. Effective January 1, 2010 all property owners will need to contact the Town Clerk to obtain the *Application and Specification Booklet* prior to constructing or reworking any driveway/field road. Upon completion of the Application and payment of \$75.00 fee a Town Inspector will review the planned construction and the Town Board will act on issuance or denial of said Application at a noticed Town meeting.

PLEASE NOTE: The US Census Bureau will be mailing out in mid-March the 2010 Decennial Census information. The Town of Belvidere Board requests that all Town Residents complete the Census information so that an accurate count is established for the Town of Belvidere. This information is utilized extensively for Town Aids and all data collected is confidential.

All meetings for conducting business for the Town of Belvidere will be held at the Cochran VFW, 100 Michaels St. (same location as Voting) on the 2nd Tuesday of each month, unless noticed different. Meeting notices will be published in the C-FC Recorder, Buffalo County Journal and Town Website.
