IMPORTANT NOTICES

- The **BBC RECYCLING Center** will be **CLOSED on Tuesdays from December 2014 through March, 2015**. Saturday hours will remain 8 a.m. to 5 p.m.
- All meetings for conducting business for the Town of Belvidere will be held at the **Cochrane VFW, 100 Michaels St.** (same location as Voting) on the Second Tuesday of each month. Meeting notices will be published in the C-FC Recorder and the Town of Belvidere Website - www.townofbelvidere.com.
- The Town of Belvidere has contracted with **Sendelbach Construction Inc, Roger Sendelbach**, for all town road maintenance. Please contact Chairman David Danzinger, (715) 495-2533 to report any down trees or road issues.
- The Town of Belvidere received a **One-Time Environmental Impact Fee in the amount of \$614,149.00 from the Wisconsin Public Service Commission**. This amount was based on the Town's share of total construction costs for the XCEL Energy CAPX2020 Transmission Line. Fund usages have restrictions for environmental purposes. To date funds have been donated to the Scenic Valley Swimming Pool Association for upgrades, Belvidere Boat Launch handicap dock construction and Cochrane VFW building upgrades for handicap accessibility and other improvements. In the upcoming years the Town will explore other local projects like the Buffalo County Recreational Trails Plan, Township Remonumentation, Local Bike Trails, and other projects that fit the criteria.
- The Town of Belvidere also receives an **Annual Impact Fee of \$73,698.00** which has no use restrictions. The Town Board will designate these funds to benefit town residents.
