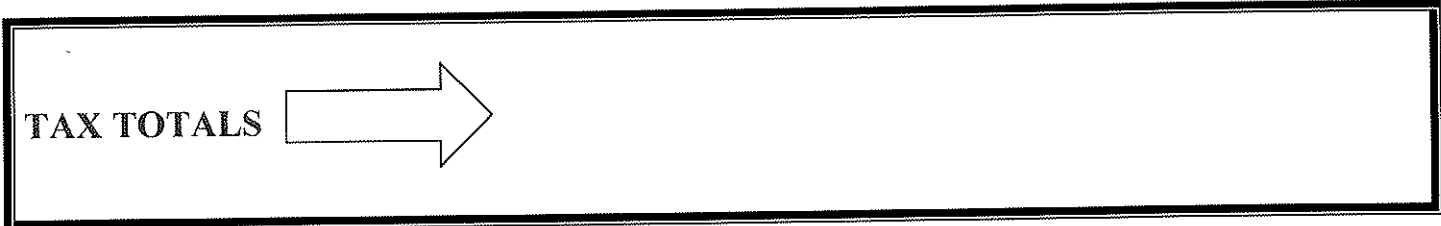

Spayed or Neutered: \$5.00 per license  
Unspayed, Unneutered: \$12.00 per license
